### **Data protection information and conditions of use**

There follows some information on how to use the website and our data protection declaration. Information on EUHealth.net as host of the website can be found on the imprint page. The following conditions of use and data protection information apply for all of the websites from EUHealth.net,

#### **Data protection declaration:**

Your private sphere is important for EUHealth.net! EUHealth.net wants to protect your private sphere and at the same time allow you to make maximum use of our Internet services. We are particularly concerned about complying with the principles of the Data Protection legislation in UK and Europe and ensuring transparency for you as the subscriber at all times.

We have listed out principles for the collection, processing, use and protection of personal information that we receive from you online or offline in the sense of the UK Data Protection Law ("personal data"). These principles relate to personal data that we receive via the EUHealth.net pages and within the scope of contractual relationships that are concluded online.

The EUHealth.net pages contain links to websites of third parties. Be very careful when using these links and check which principles the host you have chosen uses to protect your private sphere.

We may modify these data protection principles from time to time within the scope of statutory regulations. Any changes that are made become effective from the date listed. Should any modifications be necessary in future this page will always show the latest version.

#### **Personal/ Corporate log-in information.**

You can use various services on our website. In some cases these require the provision of certain personal data so that we can offer a sensible and practical service to suit your needs. This includes, for example when registering for special interest information on the planning documents, your name and e-mail address, for online subscriptions your contact data and subscriptions preferences, and for competitions your e-mail address and postal address depending on the how the competition has been organised. We will never store your data for longer than is necessary or legally required for the intended purpose.

#### **Declaration of consent.**

Wherever your consent is needed for the forwarding or use of your personal data, we will ask for your consent within the scope of our Internet services. Once you have given your consent this can be revoked at any time by sending an e-mail to our customer service department at support@euhealth.net. We will confirm your revocation by e-mail and delete the data.

We only use personal data for our own advertising and market research purposes if you have given us your express consent.

**Use of cookies.** The EUHealth.net pages use cookies to register visits to our websites. These also allow us to understand better how you wish to use our pages. Cookies are stored on your hard disk, not on our website. Cookies are not spies and cannot be used to get round the security precautions on your hard disk and "steal" information. You can adjust your browser settings at any time to refuse either our cookies or all cookies in general.

**Enquiry, changing and deletion of information.** You can contact us at any time to find out whether and which personal data about yourself is currently being stored. However, you should remember that we are unable to answer any such inquiries over the phone for data protection reasons. Please contact us for identification per e-mail from the e-mail address that you used when registering for the respective service. You have the right to demand that we delete any personal data that is stored in our system at all times. You should also contact us per e-mail if you wish us to delete or amend any personal data that you have provided online. We will do everything in our power to comply with you wishes.
